1. Synopsis of the Project and Request for Quotation

Resilience for Peace (R4P) is a five-year initiative funded by USAID and implemented by Equal Access International (EAI) to build community resilience and learning, specifically for women and children, to foster the living together between northern border communities of Cote d'Ivoire. The project fosters an "ecosystem of understanding and value of community assets" by strengthening the structures of community resilience and creating civic and economic empowerment opportunities for at-risk border communities, through improvements in natural resource management and the responsiveness of government services. Other activities facilitate networks of dialogue and public meetings to build confidence in the community, increase positive stories, generate knowledge and learning among local communities on concepts of community resilience and living together, while economic empowerment and positive approaches to youth development will enhance their employability.

The R4P project produces many reports, including multiple research reports in both French and English every year that require formatting before publication. The work for this contract will be for Year 3 from May 31, 2023 through May 30, 2024.

It is estimated that over the duration of this contract (May 31, 2023 through May 30, 2024) R4P will produce three research reports in both French and English.

10. Questions Regarding the RFQ	Each Bidder is responsible for reading very carefully and understanding fully the terms and conditions of this RFQ. All communications regarding this solicitation are to be made solely through the Issuing Office and must be submitted via email or in writing delivered to the Issuing Office no later than the date specified above. All questions received will be compiled and answered in writing and distributed to all interested Bidders.

11. Determination of Responsibility	 EAI will not enter into any type of agreement with a vendor prior to ensuring the vendor's responsibility. When assessing a vendor's responsibility, the following factors are taken into consideration: 1. Provide copies of the required valid business licenses to operate in the host country. 2. Evidence of a UEI number (explained below and instructions contained in the Annex). 3. The source, origin and nationality of the services are not from a Prohibited Country (explained below). 4. Ability to comply with required or proposed delivery or performance schedules. 5. Have a satisfactory past performance record. 6. Have a satisfactory record of integrity and business ethics. 7. Have the necessary organization, experience, accounting and operational controls, and technical skills.



	8. Be qualified and eligible to perform work under applicable laws and regulations.				
12. Geographic Code	 Under the authorized geographic code for its contract, EAI may only procure goods and services from the United States, the cooperating country/recipient country, and developing countries other than advanced developing countries. EAI must verify the source, nationality and origin, of goods and services and ensure (to the fullest extent possible) that EAI does not procure any services from prohibited countries listed by the Office of Foreign Assets Control (OFAC) as sanctioned countries. The current list of countries under comprehensive sanctions include: Cuba, Iran, North Korea, Sudan, and Syria. EAI is prohibited from facilitating any transaction by a third party if that transaction would be prohibited if performed by EAI. By submitting a quote in response to this RFQ, Bidders confirm that they are not violating the Source and Nationality requirements and that the services comply with the Geographic Code and the exclusions for prohibited countries.

Background:

Equal Access International (EAI) – a non-governmental organization (NGO) headquartered in Washington, D.C. – partners with communities around the world to co-create sustainable solutions utilizing community engagement and participatory media and technology. With funding from bilaterals, multi-laterals, foundations, and individual donors, EAI has a 20-year record of accomplishment implementing social change projects in Afghanistan, Burkina Faso, Cameroon, Chad, Côte d'Ivoire, Kenya, Mali, Nepal, Niger, Nigeria, and the Philippines.

Equal Access International (EAI) seeks an experienced Consultant to help format reports for Year 3 of the R4P project.

In February 2021, EAI began implementing Resilience for Peace (R4P), a five-year project aimed at strengthening community resilience and learning, particularly for youth and women, to counter violent extremism (CVE) in Côte d'Ivoire's (CIV) northern border areas with funding from the United States Agency for International Development (USAID).

General Description

The R4P project is carried out through February 2026 and has needs for research reports to be formatted in both French and English versions before they are released/submitted to USAID.

• Formatting support for French and English versions of project reports
